Ipswich

The Queensland Budget will directly support Ipswich with significant expenditure in 2021-22 including:

Infrastructure

\$954M

for productivity-enhancing infrastructure and capital works, estimated to support around **2,900 jobs** in this region.

Health

\$750.5M

for West Moreton Hospital and Health Services.

Education

\$157.2M

to maintain, improve and upgrade schools in Ipswich.

Ipswich will also benefit from:

Ipswich Hospital

\$166.9M

for construction projects to expand and improve facilities at the Ipswich Hospital site, including a new Mental Health Unit.

Social housing

\$51.9M

in 2021-22 to expand and improve social housing in Ipswich.

Skilling Queenslanders for Work

\$7.3M

in 2021-22 to fund more training opportunities and increase workforce participation in Ipswich.

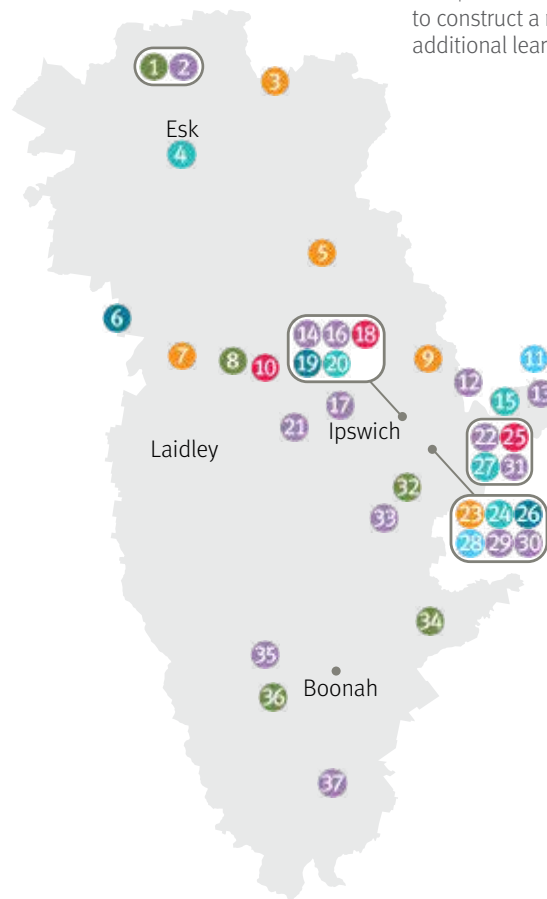

- 1 Toogoolawah Multipurpose Facility**
\$542,500 in 2021-22 out of a \$820,000 total spend to construct a new multipurpose facility and install pool heating to support fitness and active recreation at Toogoolawah. Part of the Activate! Queensland program.
- 2 Toogoolawah State High School**
\$1.9 million in 2021-22 out of a \$5.8 million total spend to deliver a new hall facility.
- 3 Somerset Dam upgrade - planning**
\$2.3 million in 2021-22 out of a \$21.1 million total spend to continue planning works for dam improvements to comply with safety standards for extreme weather events.
- 4 Esk and Laidley Hospitals**
\$712,389 in 2021-22 out of a \$2.3 million total spend for upgrades of the fire systems at Esk and Laidley Hospitals.
- 5 Wivenhoe overhauls and other projects**
\$26.5 million in 2021-22 to maintain existing assets including a major overhaul, station lighting upgrades, and replacement of other hardware.
- 6 Southern Queensland Correctional Precinct - Stage 2**
\$320 million in 2021-22 out of a \$654 million total spend to continue the expansion of the Southern Queensland Correctional Precinct with a new 1,000 bed correctional centre focusing on health and rehabilitation to reduce reoffending.
- 7 Glenore Grove Substation upgrade**
\$2.9 million in 2021-22 out of a \$7.7 million total spend to carry out substation transformer replacements to improve network performance.

- 8 Fairways Park**
\$696,000 in 2021-22 out of a \$1.7 million total spend to install multi-element playgrounds that cater for all ages and abilities, including the addition of a dog off-leash park and car park.
- 9 Mount Crosby East Bank Substation and enabling works**
\$15.8 million in 2021-22 out of a \$35.6 million total spend to improve flood resilience at the Mount Crosby East Bank Water Treatment Plant including a new substation.

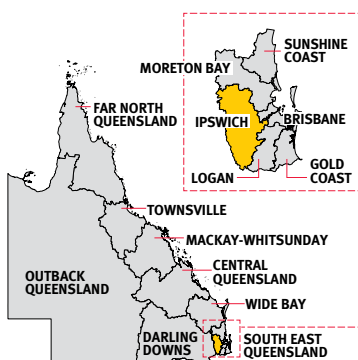
- 12 Rheinmetall Defence Australia providing local skills**
Providing vocational training and apprenticeship programs through partnerships with TAFE and universities.
- 13 Glenala State High School**
\$5.9 million in 2021-22 out of a \$15.5 million total spend to construct a new building for additional learning spaces, upgrade skills development and training facilities and upgrade the existing hall facility.
- 14 Ipswich State High School**
\$5.5 million in 2021-22 out of a \$25.5 million total spend to construct a new building for additional learning spaces.

- 17 Walloon State School**
\$1.5 million in 2021-22 out of a \$5.2 million total spend to construct a new building for additional learning spaces.
- 18 East Ipswich train station**
\$6.3 million in 2021-22 out of a \$37.7 million total spend to upgrade East Ipswich train station to provide improved access and facilities.
- 19 Murri Court**
\$936,000 in 2021-22 out of a \$4.1 million total spend (for the period 2018-19 to 2022-23 and \$1 million ongoing) to maintain a Murri Court at Ipswich.
- 20 Ipswich Hospital**
\$101.2 million in 2021-22 out of a \$166.9 million total spend for construction projects to expand and improve facilities at the Ipswich Hospital site, including a new Mental Health Unit.
- 21 Rosewood State High School**
\$2 million in 2021-22 out of a \$7 million total spend to construct a new building for additional learning spaces.
- 22 Bellbird Park State Secondary College**
\$15.4 million in 2021-22 out of a \$17 million total spend to construct a new building for additional learning spaces.
- 23 Swanbank E overhauls and other projects**
\$15.2 million in 2021-22 to maintain existing assets, including a major overhaul, and other works.
- 24 Ripley Ambulance Station**
\$2.5 million in 2021-22 out of a \$5 million total spend for the new 24/7 Ripley Ambulance Station and Local Ambulance Service Network Office to support delivery of pre-hospital ambulance responses services.
- 25 Springfield Central train station**
\$22.5 million in 2021-22 out of a \$44.5 million total spend to upgrade the Springfield Central train station park 'n' ride facility, delivering approximately 1,100 parking spaces in the precinct when completed.



- 15 The Park Centre for Mental Health, Treatment, Research and Education**
\$1.6 million in 2021-22 out of a \$2.2 million total spend for construction projects to improve facilities at The Park Centre for Mental Health, Treatment, Research and Education site.
- 16 Metal Trades, Manufacturing and Robotics Centre expansion**
\$3.3 million in 2021-22 out of a \$7 million total spend for a Metal Trades Centre expansion and a new Manufacturing and Robotics Centre at the Ipswich TAFE campus at Bundamba. Part of the Equipping TAFE for our Future.

- 10 Lowood Minden Road - SEQ Trade Enterprise Spine link**
\$679,840 in 2021-22 out of a \$1.7 million total spend to upgrade Lowood Minden Road to improve safety.
- 11 Oxley Priority Development Area**
\$15.2 million in 2021-22 out of a \$32 million total spend to develop the former Oxley Secondary College site into a residential estate to facilitate economic development and community benefit.



26 Ripley new police facility
 \$500,000 in 2021-22 out of a \$25 million total spend to progress the new police facility at Ripley.

27 Mater Public Hospital Springfield expansion
 \$177 million for an expansion that will include an emergency department, an intensive care unit, and maternity services.

28 Ripley Valley Priority Development Area Infrastructure
 \$10.2 million in 2021-22 out of a \$45 million total spend for catalyst infrastructure within the Ripley Valley Priority Development Area to support delivery of land supply for housing.

29 Ripley Valley State School
 \$5.4 million in 2021-22 out of a \$9.6 million total spend to construct stage 2 of Ripley Valley State School.

30 Ripley Valley State Secondary College
 \$9.6 million in 2021-22 out of a \$18.1 million total spend to construct stage 2 of Ripley Valley State Secondary College.


31 Springfield Central State School
 \$7.7 million in 2021-22 out of a \$9.3 million total spend to construct a new building for additional learning spaces.

32 Hardings Paddock Community Hut
 \$256,000 in 2021-22 out of a \$640,000 total spend to construct a Council operated community hut at Hardings Paddock.

33 Peak Crossing State School
 \$1.8 million in 2021-22 out of a \$2 million total spend to upgrade the administration building.


34 Wander @ The Overflow
 \$143,000 in 2021-22 out of a \$1.6 million total spend for up to 5 sustainable, self contained 1 and 2 bedroom eco accommodation pods to complement winery and event operations at The Overflow. Part of the Growing Tourism Infrastructure (2020) program.

35 Aratula State School
 \$900,000 in 2021-22 to upgrade an existing amenities block.

36 Lake Moogerah Caravan Park facilities upgrade project
 \$811,200 in 2021-22 out of a \$2 million total spend to deliver park facilities that provide a high-quality experience for visitors who come to spend time enjoying outdoor activities in this area.

37 Maroon Outdoor Education Centre
 \$1 million in 2021-22 to install a more efficient septic system.

38 Ipswich Satellite Hospital
 Part of the \$265 million total spend for delivery of seven Satellite Hospitals to manage demand and capacity while continuing to safely manage patients via alternative models of care.

Catalyst infrastructure supports more affordable housing

The Queensland Government is investing \$45 million for catalyst infrastructure in the Ripley Valley, supporting the construction of 10,800 new homes for Queensland families. This investment is unlocking more high quality and affordable land for Queenslanders, supporting economic growth for the region and helping to make Ipswich an even more liveable city.

New infrastructure such as the \$15.9 million Cumner Road project is supporting 53 jobs during construction, with the government investing \$5.2 million to complete the project in 2021-22. Construction of the \$5.91 million Barrams Road will commence soon, supporting a further 20 jobs. These roads are for the Ripley Valley Priority Development Area (PDA), located south-east of Ipswich CBD and in one of the largest urban growth areas in Australia.

The government is also investing \$15.2 million in the Oxley PDA to redevelop the former Oxley Secondary College site, supporting up to 50 construction jobs. Once completed, the redevelopment will provide new residential development and proposed retirement accommodation, while moving the new childcare centre to a flood-free zone and providing over 10 hectares of open community space.

Ipswich Motorway Stage 1 upgrade complete

The Ipswich Motorway upgrade (Rocklea to Darra Stage 1) is now complete, with the \$400 million project widening the motorway between Granard Road and Oxley Road from four to six lanes.

The jointly funded investment by the Queensland and Australian Governments has eased traffic congestion and improved road safety, flood immunity, connectivity and efficiency for road freight and other road users. More than 85,000 vehicles use this 3-kilometre stretch of road every day, including 11,000 heavy vehicles.

Seven new higher bridges were built over the Oxley Creek floodplain, while a network of new roads and over 6.5 kilometres of active transport path have transformed local connections on either side of the motorway.

Tax relief package

The government provided significant tax relief to support Queensland businesses, landlords, tenants, pubs and clubs, including:

- payroll tax refunds, waivers and deferrals for eligible businesses, targeted at small to medium businesses
- a payroll tax exemption for wages subsidised by the JobKeeper payment
- land tax rebates, waivers and deferrals for eligible taxpayers.

An estimated 320 employers in Ipswich will also benefit in 2021-22 from the higher payroll tax threshold.

STATEWIDE HIGHLIGHTS

The Queensland Government's Economic Recovery Plan continues to support businesses, workers, families and communities across the state. Our success in managing the health challenges imposed by the COVID-19 pandemic means the state's **\$360 billion** economy has begun to recover sooner and is stronger than the rest of Australia.

2021-22 Budget highlights include:

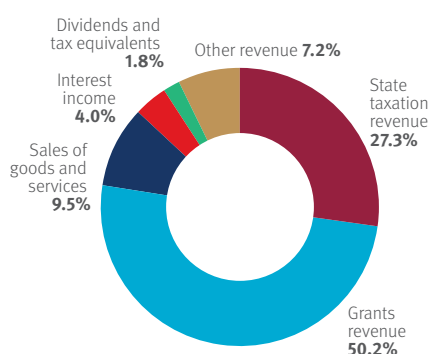
- Record health investment of **\$22.2 billion** will continue to provide a world-class health system, which is also critical to effectively manage the ongoing risks of COVID-19.
- The new **\$3.34 billion** Queensland Jobs Fund focuses on investment attraction and industry development to attract the investment needed to drive ongoing growth, and provide wider economic and employment benefits.
- The **\$52.2 billion** capital program over the forward estimates will help create many thousands of ongoing jobs, including an estimated **46,500** direct jobs in 2021-22.
- **\$460 million** toward targeted investments in flagship skills and training and employment programs Skilling Queenslanders for Work and a revitalised Back to Work program.

Ten new schools

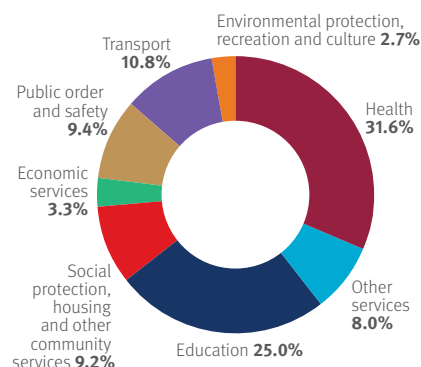
The 2021-22 Budget includes \$913.7 million for 10 new schools to open in 2023 and 2024, as part of the Building Future Schools Program.

- 2023 – primary schools in Yarrabilba, Ripley and the Augustine Heights/Redbank Plains area, and a secondary school in Palmview
- 2024 – primary schools in Redland Bay, Bellbird Park and the Logan Reserve/Crestmead/Park Ridge area, and secondary schools in Springfield and the Collingwood Park/Redbank Plains and Logan Reserve/Park Ridge areas.
